

SEVENTH ANNUAL REPORT OF THE PRESIDENT Covering the Calendar Year 1978

MARCH 1979

TO THE CONGRESS OF THE UNITED STATES:

In accordance with the provisions of Section 6(c) of the Federal Advisory Committee Act (Public Law 92-463), I am transmitting the seventh annual report on the status of Federal advisory committees.

This report reflects further progress toward accomplishing the objectives I set in 1977: to assure that unnecessary committees are terminated, and new committees are established only when they are essential to meet the responsibilities of the government. At the end of 1978:

- The total number of committees was 816, 59 fewer than at the beginning of the year; and
- Since the beginning of 1977 the total number of committees has been reduced by 343 (from 1,159).

Introduction

This is the Seventh Annual Report of the President to the Congress, covering calendar year 1978, on the activities, status, and changes in the composition of Federal Advisory Committees, as required by the Federal Advisory Committee Act (Public Law 92-463, October 6, 1972). It is a summary of the information required by section 6(c) of the Act (which is forwarded separately to the Congress).

Advisory committees can be of great value. They contribute to the "openness" of Governmental decision-making, and provide advice and information not otherwise available to the Government. Their functions range from providing broad policy advice on major national issues, to providing specific technical recommendations on particular problems. However, they may also outlive their usefulness, or become ineffective, or require restructuring to meet their responsibilities. Recognizing this, on February 25, 1977, President Carter directed a zero-base review of all committees. This review resulted in the decrease of 284 committees by the end of 1977, from the 1,159 reported at the end of 1976.

The Committee Management Secretariat, responsible for all matters relating to advisory committees, was transferred from the Office of Management and Budget to the General Services Administration, in accordance with Reorganization Plan No. 1 of 1977, on November 20, 1977, by Executive Order 12024. To continue to meet the President's objectives, another zero-base review of all committees was conducted during 1978 by the General Services Administration, to ensure that unnecessary committees continued to be terminated, and that those which were recommended for continuation were effective and met a compelling need to carry out the responsibilities of the Government.

As a result of that review, as of December 31, 1978, there were 816 committees, a decrease of 59 from the 875 reported at the end of 1977. The change in number reflects:

New committees established during 1978	204
Committees terminated during 1978	263

As noted in prior reports, the largest number of committees is concentrated in a small number of departments or agencies: six had 40 or more advisory committees in 1977. At the end of 1978, however, only five had more than 40. During 1978, one agency (Small Business Administration) reduced its committees from 65 to 13:

Of the 1,079 committees which were in existence at some time during 1978, 32 percent (348 committees) were directed by law; 36 percent (383 committees) were authorized - but not directed to be established - by law; 30 percent (322 committees) were established under general agency or departmental authorities; and the remaining 26 committees (2 percent) were established by Presidential directive. A total of 22,348 persons served on these committees at some time during the year.

The total Federal cost (as reported by individual agencies) to operate and support advisory committees during 1978 was \$68,405,002. These costs include compensation, travel, and per diem allowances for committee members (where paid); staff support costs (including salary and other allowances for Federal employees directly supporting the committees); consultant fees; space; printing (and other services); and supplies. Costs for individual committees ranged from zero for some to more than one million dollars for each of eight others.

It is estimated that \$74,060,683 will be necessary for the expenses of advisory committees in calendar year 1979, and this amount is incorporated in the President's budget recommendations to the Congress.

- (1) All advisory committees in existence at the end of calendar year 1978, alphabetically, with the responsible agency indicated;
- (2) Presidential Advisory Committees at the end of calendar year 1978; and
- (3) All advisory committees new, in existence, and terminated during calendar year 1978, alphabetically by agency.

The Federal Advisory Committee Act required the establishment of procedures and guidelines to improve advisory committee management, and to foster public accountability of existing committees. The major documents for meeting these requirements are included in this report as Appendices A through D.

This summary report and the detailed information in the agency compilations on which it is based (on Standard Forms 248, 248A, 249, 249A, and 250 of which facsimiles are shown in Appendix D) will be made available on microfilm. In addition, in the past (for 1974, 1975, and 1976) the Subcommittee on Reports, Accounting, and Management of the Committee on Governmental Affairs, United States Senate, and (for 1977) the Subcommittee on Energy, Nuclear Proliferation, and Federal Services of the Committee on Governmental Affairs, United States Senate, published Membership Indexes which were microfilmed. All microfilm is made available in the Library of Congress, or the National Archives and Records Service Reading Rooms in Washington, DC; Boston, MA; New York, NY; Atlanta, GA; Chicago, IL; Kansas City, MO; Fort Worth, TX; Denver, CO; San Francisco, CA; and Auburn, WA.

APPENDIX A

Federal Advisory Committee Act (Public Law 92-463)

(Section 10(d) of the Federal Advisory Committee Act was amended by Section 5(c) of Public Law 94-409, "Government in the Sunshine Act," effective March 12, 1977.)

92nd Congress, H. R. 4383
October 6, 1972

An Act

86 STAT. 770

To authorize the establishment of a system governing the creation and operation of advisory committees in the executive branch of the Federal Government, and for other purposes.

Be it enacted by the Senate and House of Representatives of the United States of America in Congress assembled, That this Act may be cited as the "Federal Advisory Committee Act".

Federal Advisory Committee Act.

FINDINGS AND PURPOSES

SEC. 2. (a) The Congress finds that there are numerous committees, boards, commissions, councils, and similar groups which have been established to advise officers and agencies in the executive branch of the Federal Government and that they are frequently a useful and beneficial means of furnishing expert advice, ideas, and diverse opinions to the Federal Government.

(b) The Congress further finds and declares that—

(1) the need for many existing advisory committees has not been adequately reviewed;

(2) new advisory committees should be established only when they are determined to be essential and their number should be kept to the minimum necessary;

(3) advisory committees should be terminated when they are no longer carrying out the purposes for which they were established;

(4) standards and uniform procedures should govern the establishment, operation, administration, and duration of advisory committees;

(5) the Congress and the public should be kept informed with respect to the number, purpose, membership, activities, and cost of advisory committees; and

(6) the function of advisory committees should be advisory only, and that all matters under their consideration should be determined, in accordance with law, by the official, agency, or officer involved.

DEFINITIONS

SEC. 3. For the purpose of this Act—

(1) The term "Director" means the Director of the Office of Management and Budget.

(2) The term "advisory committee" means any committee, board, commission, council, conference, panel, task force, or other similar group, or any subcommittee or other subgroup thereof (hereafter in this paragraph referred to as "committee"), which is—

(A) established by statute or reorganization plan, or

(B) established or utilized by the President, or

(C) established or utilized by one or more agencies,

in the interest of obtaining advice or recommendations for the President or one or more agencies or officers of the Federal Government, except that such term excludes (i) the Advisory Commission on Intergovernmental Relations, (ii) the Commission on Government Procurement, and (iii) any committee which is composed wholly of full-time officers or employees of the Federal Government.

(3) The term "agency" has the same meaning as in section 551(1) of title 5, United States Code.

(4) The term "Presidential advisory committee" means an advisory committee which advises the President.

APPLICABILITY

SEC. 4. (a) The provisions of this Act or of any rule, order, or regulation promulgated under this Act shall apply to each advisory committee except to the extent that any Act of Congress establishing any such advisory committee specifically provides otherwise.

Restrictions.

(b) Nothing in this Act shall be construed to apply to any advisory committee established or utilized by—

- (1) the Central Intelligence Agency; or
- (2) the Federal Reserve System.

(c) Nothing in this Act shall be construed to apply to any local civic group whose primary function is that of rendering a public service with respect to a Federal program, or any State or local committee, council, board, commission, or similar group established to advise or make recommendations to State or local officials or agencies.

RESPONSIBILITIES OF CONGRESSIONAL COMMITTEES

Review.

SEC. 5. (a) In the exercise of its legislative review function, each standing committee of the Senate and the House of Representatives shall make a continuing review of the activities of each advisory committee under its jurisdiction to determine whether such advisory committee should be abolished or merged with any other advisory committee, whether the responsibilities of such advisory committee should be revised, and whether such advisory committee performs a necessary function not already being performed. Each such standing committee shall take appropriate action to obtain the enactment of legislation necessary to carry out the purpose of this subsection.

Guidelines.

(b) In considering legislation establishing, or authorizing the establishment of any advisory committee, each standing committee of the Senate and of the House of Representatives shall determine, and report such determination to the Senate or to the House of Representatives, as the case may be, whether the functions of the proposed advisory committee are being or could be performed by one or more agencies or by an advisory committee already in existence, or by enlarging the mandate of an existing advisory committee. Any such legislation shall—

(1) contain a clearly defined purpose for the advisory committee;

(2) require the membership of the advisory committee to be fairly balanced in terms of the points of view represented and the functions to be performed by the advisory committee;

(3) contain appropriate provisions to assure that the advice and recommendations of the advisory committee will not be inappropriately influenced by the appointing authority or by any special interest, but will instead be the result of the advisory committee's independent judgment;

(4) contain provisions dealing with authorization of appropriations, the date for submission of reports (if any), the duration of the advisory committee, and the publication of reports and other materials, to the extent that the standing committee determines the provisions of section 10 of this Act to be inadequate; and

(5) contain provisions which will assure that the advisory committee will have adequate staff (either supplied by an agency or employed by it), will be provided adequate quarters, and will have funds available to meet its other necessary expenses.

(c) To the extent they are applicable, the guidelines set out in subsection (b) of this section shall be followed by the President, agency heads, or other Federal officials in creating an advisory committee.

RESPONSIBILITIES OF THE PRESIDENT

SEC. 6. (a) The President may delegate responsibility for evaluating and taking action, where appropriate, with respect to all public recommendations made to him by Presidential advisory committees.

(b) Within one year after a Presidential advisory committee has submitted a public report to the President, the President or his delegate shall make a report to the Congress stating either his proposals for action or his reasons for inaction, with respect to the recommendations contained in the public report.

Report to Congress.

(c) The President shall, not later than March 31 of each calendar year (after the year in which this Act is enacted), make an annual report to the Congress on the activities, status, and changes in the composition of advisory committees in existence during the preceding calendar year. The report shall contain the name of every advisory committee, the date of and authority for its creation, its termination date or the date it is to make a report, its functions, a reference to the reports it has submitted, a statement of whether it is an ad hoc or continuing body, the dates of its meetings, the names and occupations of its current members, and the total estimated annual cost to the United States to fund, service, supply, and maintain such committee. Such report shall include a list of those advisory committees abolished by the President, and in the case of advisory committees established by statute, a list of those advisory committees which the President recommends be abolished together with his reasons therefor. The President shall exclude from this report any information which, in his judgment, should be withheld for reasons of national security, and he shall include in such report a statement that such information is excluded.

Annual report to Congress.

Exclusion.

RESPONSIBILITIES OF THE DIRECTOR, OFFICE OF MANAGEMENT AND BUDGET

SEC. 7. (a) The Director shall establish and maintain within the Office of Management and Budget a Committee Management Secretariat, which shall be responsible for all matters relating to advisory committees.

Committee Management Secretariat. Establishment.

(b) The Director shall, immediately after the enactment of this Act, institute a comprehensive review of the activities and responsibilities of each advisory committee to determine—

Review.

- (1) whether such committee is carrying out its purpose;
- (2) whether, consistent with the provisions of applicable statutes, the responsibilities assigned to it should be revised;
- (3) whether it should be merged with other advisory committees; or
- (4) whether it should be abolished.

The Director may from time to time request such information as he deems necessary to carry out his functions under this subsection. Upon the completion of the Director's review he shall make recommendations to the President and to either the agency head or the Congress with respect to action he believes should be taken. Thereafter, the Director shall carry out a similar review annually. Agency heads shall cooperate with the Director in making the reviews required by this subsection.

Performance guidelines.

(c) The Director shall prescribe administrative guidelines and management controls applicable to advisory committees, and, to the maximum extent feasible, provide advice, assistance, and guidance to advisory committees to improve their performance. In carrying out his functions under this subsection, the Director shall consider the recommendations of each agency head with respect to means of improving the performance of advisory committees whose duties are related to such agency.

Uniform pay guidelines.

(d) (1) The Director, after study and consultation with the Civil Service Commission, shall establish guidelines with respect to uniform fair rates of pay for comparable services of members, staffs, and consultants of advisory committees in a manner which gives appropriate recognition to the responsibilities and qualifications required and other relevant factors. Such regulations shall provide that—

(A) no member of any advisory committee or of the staff of any advisory committee shall receive compensation at a rate in excess of the rate specified for GS-18 of the General Schedule under section 5332 of title 5, United States Code; and

Travel expenses.

(B) such members, while engaged in the performance of their duties away from their homes or regular places of business, may be allowed travel expenses, including per diem in lieu of subsistence, as authorized by section 5703 of title 5, United States Code, for persons employed intermittently in the Government service.

(2) Nothing in this subsection shall prevent—

(A) an individual who (without regard to his service with an advisory committee) is a full-time employee of the United States, or

(B) an individual who immediately before his service with an advisory committee was such an employee, from receiving compensation at the rate at which he otherwise would be compensated (or was compensated) as a full-time employee of the United States.

Expense recommendations.

(e) The Director shall include in budget recommendations a summary of the amounts he deems necessary for the expenses of advisory committees, including the expenses for publication of reports where appropriate.

RESPONSIBILITIES OF AGENCY HEADS

Sec. 8. (a) Each agency head shall establish uniform administrative guidelines and management controls for advisory committees established by that agency, which shall be consistent with directives of the Director under section 7 and section 10. Each agency shall maintain systematic information on the nature, functions, and operations of each advisory committee within its jurisdiction.

Advisory Committee Management Control Officer, designation.

(b) The head of each agency which has an advisory committee shall designate an Advisory Committee Management Officer who shall—

(1) exercise control and supervision over the establishment, procedures, and accomplishments of advisory committees established by that agency;

(2) assemble and maintain the reports, records, and other papers of any such committee during its existence; and

(3) carry out, on behalf of that agency, the provisions of section 552 of title 5, United States Code, with respect to such reports, records, and other papers.

ESTABLISHMENT AND PURPOSE OF ADVISORY COMMITTEES

Sec. 9. (a) No advisory committee shall be established unless such establishment is—

(1) specifically authorized by statute or by the President; or

(2) determined as a matter of formal record, by the head of the agency involved after consultation with the Director, with timely notice published in the Federal Register, to be in the public interest in connection with the performance of duties imposed on that agency by law.

Publication in Federal Register.

(b) Unless otherwise specifically provided by statute or Presidential directive, advisory committees shall be utilized solely for advisory functions. Determinations of action to be taken and policy to be expressed with respect to matters upon which an advisory committee reports or makes recommendations shall be made solely by the President or an officer of the Federal Government.

(c) No advisory committee shall meet or take any action until an advisory committee charter has been filed with (1) the Director, in the case of Presidential advisory committees, or (2) with the head of the agency to whom any advisory committee reports and with the standing committees of the Senate and of the House of Representatives having legislative jurisdiction of such agency. Such charter shall contain the following information:

Charter, filing.

Contents.

- (A) the committee's official designation;
- (B) the committee's objectives and the scope of its activity;
- (C) the period of time necessary for the committee to carry out its purposes;
- (D) the agency or official to whom the committee reports;
- (E) the agency responsible for providing the necessary support for the committee;
- (F) a description of the duties for which the committee is responsible, and, if such duties are not solely advisory, a specification of the authority for such functions;
- (G) the estimated annual operating costs in dollars and man-years for such committee;
- (H) the estimated number and frequency of committee meetings;
- (I) the committee's termination date, if less than two years from the date of the committee's establishment; and
- (J) the date the charter is filed.

A copy of any such charter shall also be furnished to the Library of Congress.

ADVISORY COMMITTEE PROCEDURES

Sec. 10. (a) (1) Each advisory committee meeting shall be open to the public.

Meetings.

(2) Except when the President determines otherwise for reasons of national security, timely notice of each such meeting shall be published in the Federal Register, and the Director shall prescribe regulations to provide for other types of public notice to insure that all interested persons are notified of such meeting prior thereto.

Notice. Publication in Federal Register. Regulations.

(3) Interested persons shall be permitted to attend, appear before, or file statements with any advisory committee, subject to such reasonable rules or regulations as the Director may prescribe.

(b) Subject to section 552 of title 5, United States Code, the records, reports, transcripts, minutes, appendixes, working papers, drafts, studies, agenda, or other documents which were made available to or prepared for or by each advisory committee shall be available for public inspection and copying at a single location in the offices of the advisory committee or the agency to which the advisory committee reports until the advisory committee ceases to exist.

(c) Detailed minutes of each meeting of each advisory committee shall be kept and shall contain a record of the persons present, a complete and accurate description of matters discussed and conclusions reached, and copies of all reports received, issued, or approved by the

advisory committee. The accuracy of all minutes shall be certified to by the chairman of the advisory committee.

Annual report.

(d) Subsections (a)(1) and (a)(3) of this section shall not apply to any advisory committee meeting which the President, or the head of the agency to which the advisory committee reports, determines is concerned with matters listed in section 552(b) of title 5, United States Code. Any such determination shall be in writing and shall contain the reasons for such determination. If such a determination is made, the advisory committee shall issue a report at least annually setting forth a summary of its activities and such related matters as would be informative to the public consistent with the policy of section 552(b) of title 5, United States Code.

Federal officer

(e) There shall be designated an officer or employee of the Federal Government to chair or attend each meeting of each advisory committee. The officer or employee so designated is authorized, whenever he determines it to be in the public interest, to adjourn any such meeting. No advisory committee shall conduct any meeting in the absence of that officer or employee.

(f) Advisory committees shall not hold any meetings except at the call of, or with the advance approval of, a designated officer or employee of the Federal Government, and in the case of advisory committees (other than Presidential advisory committees), with an agenda approved by such officer or employee.

AVAILABILITY OF TRANSCRIPTS

SEC. 11. (a) Except where prohibited by contractual agreements entered into prior to the effective date of this Act, agencies and advisory committees shall make available to any person, at actual cost of duplication, copies of transcripts of agency proceedings or advisory committee meetings.

(b) As used in this section "agency proceeding" means any proceeding as defined in section 551(12) of title 5, United States Code.

FISCAL AND ADMINISTRATIVE PROVISIONS

Recordkeeping.

SEC. 12. (a) Each agency shall keep records as will fully disclose the disposition of any funds which may be at the disposal of its advisory committees and the nature and extent of their activities. The General Services Administration, or such other agency as the President may designate, shall maintain financial records with respect to Presidential advisory committees. The Comptroller General of the United States, or any of his authorized representatives, shall have access, for the purpose of audit and examination, to any such records.

(b) Each agency shall be responsible for providing support services for each advisory committee established by or reporting to it unless the establishing authority provides otherwise. Where any such advisory committee reports to more than one agency, only one agency shall be responsible for support services at any one time. In the case of Presidential advisory committees, such services may be provided by the General Services Administration.

Depository.

SEC. 13. Subject to section 552 of title 5, United States Code, the Director shall provide for the filing with the Library of Congress of at least eight copies of each report made by every advisory committee and, where appropriate, background papers prepared by consultants. The Librarian of Congress shall establish a depository for such reports and papers where they shall be available to public inspection and use.

TERMINATION OF ADVISORY COMMITTEES

Sec. 14. (a) (1) Each advisory committee which is in existence on the effective date of this Act shall terminate not later than the expiration of the two-year period following such effective date unless—

(A) in the case of an advisory committee established by the President or an officer of the Federal Government, such advisory committee is renewed by the President or that officer by appropriate action prior to the expiration of such two-year period; or

(B) in the case of an advisory committee established by an Act of Congress, its duration is otherwise provided for by law.

(2) Each advisory committee established after such effective date shall terminate not later than the expiration of the two-year period beginning on the date of its establishment unless—

(A) in the case of an advisory committee established by the President or an officer of the Federal Government such advisory committee is renewed by the President or such officer by appropriate action prior to the end of such period; or

(B) in the case of an advisory committee established by an Act of Congress, its duration is otherwise provided for by law.

(b) (1) Upon the renewal of any advisory committee, such advisory committee shall file a charter in accordance with section 9(c). Renewal.

(2) Any advisory committee established by an Act of Congress shall file a charter in accordance with such section upon the expiration of each successive two-year period following the date of enactment of the Act establishing such advisory committee.

(3) No advisory committee required under this subsection to file a charter shall take any action (other than preparation and filing of such charter) prior to the date on which such charter is filed.

(c) Any advisory committee which is renewed by the President or any officer of the Federal Government may be continued only for successive two-year periods by appropriate action taken by the President or such officer prior to the date on which such advisory committee would otherwise terminate. Continuation.

EFFECTIVE DATE

Sec. 15. Except as provided in section 7(b), this Act shall become effective upon the expiration of ninety days following the date of enactment.

APPENDIX B

Executive Order 12024

THE PRESIDENT

Relating to the Transfer of Certain Advisory Committee Functions

Executive Order 12024

December 1, 1977

By virtue of the authority vested in me by the Constitution and statutes of the United States of America, including the Federal Advisory Committee Act, as amended (5 U.S.C. App. I), Section 301 of Title 3 of the United States Code, Section 202 of the Budget and Accounting Procedures Act of 1950 (31 U.S.C. 581c), and Section 7 of Reorganization Plan No. 1 of 1977 (42 FR 56101 (October 21, 1977)), and as President of the United States of America, in accord with the transfer of advisory committee functions from the Office of Management and Budget to the General Services Administration provided by Reorganization Plan No. 1 of 1977, it is hereby ordered as follows:

SECTION 1. The transfer, provided by Section 5F of Reorganization Plan No. 1 of 1977 (42 FR 56101), of certain functions under the Federal Advisory Committee Act, as amended (5 U.S.C. App. I), from the Office of Management and Budget and its Director to the Administrator of General Services is hereby effective.


SEC. 2. There is hereby delegated to the Administrator of General Services all the functions vested in the President by the Federal Advisory Committee Act, as amended, except that, the annual report to the Congress required by Section 6(c) of that Act shall be prepared by the Administrator for the President's consideration and transmittal to the Congress.

SEC. 3. The Director of the Office of Management and Budget shall take all actions necessary or appropriate to effectuate the transfer of functions provided in this Order, including the transfer of funds, personnel and positions, assets, liabilities, contracts, property, records, and other items related to the functions transferred.

SEC. 4. Executive Order No. 11769 of February 21, 1974 is hereby revoked.

SEC. 5. Any rules, regulations, orders, directives, circulars, or other actions taken pursuant to the functions transferred or reassigned as provided in this Order from the Office of Management and Budget to the Administrator of General Services, shall remain in effect as if issued by the Administrator until amended, modified, or revoked.

SEC. 6. This Order shall be effective November 20, 1977.

TO THE HEADS OF EXECUTIVE DEPARTMENTS AND ESTABLISHMENTS

SUBJECT: Advisory Committee Management

1. Purpose. This Circular provides guidance for implementation of the Federal Advisory Committee Act, Public Law No. 92-463, 5 U.S.C. App. I, (hereinafter referred to as the "Act") and Executive Order No. 11769, entitled "Advisory Committee Management."

2. Rescission. This Circular rescinds and supersedes the December 26, 1972 revision of Circular No. A-63 and the OMB/Department of Justice Memorandum on implementation of the Federal Advisory Committee Act (see 38 Fed. Reg. 2306 (1973)).

3. Policy. In the application of this Circular, these principles should be followed.

a. Advisory Committee meetings should be open to the public. Exceptions should be held to the minimum, carefully grounded in law and explained in detail. The emphasis should be on the free flow of information to the public.

b. Advisory committees should be limited to those that are essential. Any advisory committees which are not fulfilling their purposes should be terminated.

c. The recommendations of advisory committees should be considered by those who sought advice, while responsible Federal officers retain authority for decisions.

d. Standards and uniform procedures for the creation, operation, and duration of advisory committees should be established.

4. Definitions. For purposes of this Circular --

a. "Act" means the Federal Advisory Committee Act.

(No. A-63)

b. "Advisory Committee" has the meaning set forth in Section 3 of the Act.

5. Responsibilities.

a. The Office of Management and Budget (OMB). In general, the functions of the Director under the Act and under Executive Order 11769 shall be carried out by the Committee Management Secretariat of OMB.

b. Departments and agencies.

(1) The head of each agency which uses an advisory committee shall insure compliance with the Act and this Circular and shall issue regulations which apply to all advisory committees established or used by the agency.

(2) The head of each agency which uses an advisory committee shall designate an Advisory Committee Management Officer who shall carry out the functions specified in Section 8(b) of the Act and this Circular. The name of each Advisory Committee Management Officer shall be provided to the OMB Secretariat.

(3) Each agency shall maintain information on the nature, functions, and operations of each of its advisory committees. This shall include a complete set of the charters of the agency's advisory committees, and copies of the annual reports on its advisory committees in a single location.

6. Creation of advisory committees.

a. When an agency proposes to establish an advisory committee not specifically authorized by statute or by the President, the agency head must consult with the OMB Secretariat. Such "consultation" may be in the form of a letter from the agency head describing the nature and purpose of the proposed advisory committee, including an explanation of why the functions of the proposed committee could not be performed by the agency or by an existing committee. The letter, in addition, should describe the agency's plan to attain balanced membership on the proposed committee. If the OMB Secretariat is satisfied that establishment of the advisory committee would be in accord with the Act, the agency head shall certify in writing that creation of the advisory committee is in the public interest. This

certification and a description of the nature and purpose of the committee shall be published in the Federal Register at least 15 days prior to the filing of the committee's charter. The OMB Secretariat may, for good cause, authorize a shorter period of time between publication of the notice and the filing of the charter.

If not satisfied that establishment of the advisory committee would be in accordance with the Act, the OMB Secretariat shall inform the agency head in writing within 15 days of receipt of the agency letter.

b. Unless specifically provided otherwise by statute or Presidential directive, advisory committees shall be utilized solely for advisory functions.

c. (1) Each advisory committee shall file a charter complying with Section 9(c) of the Act. This requirement applies to committees "utilized" as advisory committees, though not established for that purpose.

(2) A copy of each charter shall be furnished to the Library of Congress at the time of filing. Copies should be sent to:

7. Termination and renewal of advisory committees.

a. Each nonstatutory advisory committee (i.e., not established by statute or reorganization plan) which is in existence on January 5, 1973, shall terminate no later than January 5, 1975, unless it is renewed by the President or the agency head prior to January 5, 1975.

Before such a committee can be renewed by an agency, the agency head must determine that renewal is necessary and shall inform the OMB Secretariat of his determination and the reasons for it not more than 60 days before the committee expires. If the Secretariat concurs, the agency head shall publish notice of the renewal in the Federal Register and shall file a new charter.

Any advisory committee which is renewed shall continue for not more than two years unless, prior to the expiration of that period, it is renewed. Each such advisory committee established by the President or a Federal officer after January 5, 1973, shall terminate not later than two years after its establishment unless prior to that time it is renewed.

b. Each advisory committee established by statute or reorganization plan which is in existence on January 5, 1973, shall terminate by January 5, 1975, unless its duration is otherwise provided for by law.

(1) Each such advisory committee which is established after January 5, 1973, shall terminate not later than two years after its establishment unless its duration is otherwise provided for by law.

(2) Any such statutory advisory committee shall file a new charter upon the expiration of each successive two-year period following the date of enactment of the statute establishing the committee.

c. No advisory committee required by Section 14(b) of the Act to file a new charter shall take any action, other than preparation and filing of such charter, between the date the new charter is required, and the date it is filed.

8. Operation of advisory committees.

a. Calling of meetings.

(1) No advisory committee shall hold any meeting except at the call of or with the advance approval of the Federal official designated in accordance with Sec. 10(e) of the Act and this Circular. (See 8f below.)

(2) Except with respect to Presidential advisory committees, each meeting of an advisory committee shall be conducted in accordance with an agenda approved by the Federal official. The agenda shall list the matters to be considered at the meeting. It shall also indicate when any part of the meeting will concern matters within the exemptions of the Freedom of Information Act, 5 U.S.C. 552(b).

b. Notice of meetings.

(No. A-63)

(1) Except when the Director determines otherwise for reasons of national security, timely notice of each advisory committee meeting, whether open or closed to the public, shall be published in the Federal Register. In addition to the notice in the Federal Register, other forms of notice should be used, for example, press releases and notices by mail. Where practicable, agencies should maintain lists of people and organizations interested in particular advisory committees and notify them of meetings by mail.

(2) Such notice should state the name of the advisory committee, the time, place and purpose of the meeting (including where appropriate, a summary of the agenda). Notices ordinarily should state that meetings are open to the public, or, explain why any part is closed.

(3) Such notice should be published at least 15 days before the date of the meeting except that shorter notice may be provided in emergency situations, and the reasons for such emergency exceptions shall be made part of the meeting notice. Agencies should keep in mind the time the Federal Register needs to get notices into print, and plan accordingly.

(4) Notice is not required when the Director has determined that it should not be published for reasons of national security. Any agency advisory committee which seeks such a determination, shall submit its request and a statement of reasons to the Director at least 30 days before the meeting is scheduled.

c. Public participation. The agency head or, in the case of a Presidential advisory committee, the chairman of the committee shall, for any advisory committee meeting, all or part of which is open to the public, assure compliance with the following rules:

(1) Meetings shall be held at a reasonable time and at a place that is reasonably accessible to the public.

(2) The size of the meeting room shall be determined by such factors as the size of the committee, the number of members of the public who could reasonably be expected to attend, the number of persons who attended similar meetings in the past and the resources and facilities available.

(3) Any member of the public shall be permitted to file a written statement with the committee.

(4) Interested persons may be permitted by the committee chairman to speak at the meeting in accordance with procedures established by the committee.

d. Closed meetings.

(1) Section 10(d) of the Act states that the provisions concerning open meetings and public participation "shall not apply to any advisory committee meeting which the President, or the head of the agency to which the advisory committee reports, determines is concerned with matters listed in . . ." 5 U.S.C. 552(b), the exemptions of the Freedom of Information Act.

(2) An advisory committee which seeks to have all or part of a meeting closed on the basis of 5 U.S.C. 552(b) shall notify the agency head or, in the case of a Presidential advisory committee, the Director at least 30 days before the scheduled date of the meeting. The notification shall be in writing and shall specify all the reasons why any part of the meeting should be closed.

If the agency head or the Director finds the request to be warranted and in accordance with the policy of the Act, the request shall be granted. The determination of the agency head or the Director shall be in writing and shall state the specific reasons for closing all or part of the meeting. The determination itself shall be made available to the public on request. The agency head or the Director may delegate responsibility for making the above determinations. However, in any case where a determination to close a meeting is made by a delegate of the agency head, the determination should be reviewed by the agency General Counsel.

(3) When a meeting is closed, the advisory committee shall issue a report at least annually setting forth a summary of its activities and related matters which are informative to the public consistent with the policy of 5 U.S.C. 552(b). Notice of availability of such annual report shall be published in the Federal Register no later than 60 days after its completion. The notice shall include instructions which will allow the public access to the report.

e. Minutes. Detailed minutes shall be kept of each advisory committee meeting. The minutes shall include: the time and place of the meeting; a list of advisory committee members and staff and agency employees present at the meeting; a complete summary of matters discussed and conclusions reached; copies of all reports received, issued, or approved by the advisory committee; a description of the extent to which the meeting was open to the public; and a description of public participation, including a list of members of the public who presented oral or written statements and an estimate of the number of members of the public who attended the meeting.

The chairman of the advisory committee shall certify to the accuracy of the minutes.

f. Designated Federal employee.

(1) With regard to an advisory committee used by an agency, the agency head shall designate a Federal officer or employee as set forth in Section 10(e) of the Act and determine whether he is to chair or attend the meetings. With regard to Presidential advisory committees such officer or employee may be designated, and his role determined by the Director. Ordinarily, the designated Federal employee should serve on a continuing basis.

(2) No advisory committee shall conduct a meeting in the absence of the designated Federal employee.

(3) The designated Federal employee shall be authorized to adjourn any advisory committee meeting, whenever he determines adjournment to be in the public interest.

9. Reports on advisory committees.

a. The President has delegated, in Executive Order 11769, responsibility for preparation of the annual report required by Section 6(c) of the Act to the Administrator of General Services. The General Services Administration (GSA) will provide appropriate reporting instructions.

b. Two copies of each public report of each Presidential advisory committee shall be submitted to the OMB Committee Management Secretariat at the time of the submission to the President.

10. Comprehensive Review. The annual review required by Section 7(b) of the Act shall be conducted on a calendar-year basis. Agencies may schedule the review so that its results are incorporated in the annual report of advisory committees. The review should examine all advisory committees, and terminate those no longer useful. Advisory committees specifically created by statute or Executive Order should be reviewed, and if appropriate, their termination recommended. The comprehensive review should include, among other things, a summary of the total number of advisory committee meetings, the number of closed or partially closed meetings, and a recapitulation of the exemptions in the Freedom of Information Act used as a basis for closing meetings. The review should also comment in some detail on agency efforts and procedures to insure balanced membership on its advisory committees. The results of the comprehensive review should be included in the annual report to the Administrator of General Services.

11. Uniform pay guidelines.

a. Pay for members of an advisory committee.

(1) Subject to the provisions of this paragraph, an agency shall fix the pay of the members of an advisory committee to the daily equivalent of a rate of the General Schedule in 5 U.S.C. 5332 unless the members are appointed as consultants and compensated as provided in 11c below.

(2) In determining an appropriate rate of pay for the members of an advisory committee, an agency shall give consideration to the significance, scope, and technical complexity of the matters with which the advisory committee is concerned and the qualifications required of the members of the advisory committee.

(3) An agency may not fix the pay of the members of an advisory committee at a rate higher than the daily equivalent of the maximum rate for GS-15 unless the head of the agency has personally determined that, under the factors set forth in paragraph 11b(2), a higher rate of pay is justified and necessary. Such a determination must be reviewed by the head of the agency annually.

b. Pay for the staff of an advisory committee.

(1) Subject to the provisions of b(2), below, an agency shall fix the pay of each member of the staff of an advisory committee at a rate of the General Schedule in which the staff member's position would appropriately be placed were the General Schedule classification system in chapter 51 of title 5, United States Code, applicable to the position.

(2) An agency may not fix the pay of a member of the staff of an advisory committee at a rate higher than the daily equivalent of the maximum rate for GS-15 unless the head of the agency has determined that, under the General Schedule classification system, the staff member's position would appropriately be placed in the General Schedule grade higher than GS-15. Such a determination must be reviewed by the head of the agency annually.

c. Pay for consultants to an advisory committee. An agency shall fix the pay of a consultant to an advisory committee after giving consideration to the qualifications required of the consultant and the significance, scope, and technical complexity of the work. The rate of pay shall not exceed the maximum rate of pay which the agency may pay experts and consultants under 5 U.S.C. 3109.

d. Voluntary services of an advisory committee member. The provisions of this section shall not prevent an agency from accepting the voluntary services of a member of an advisory committee, or a member of the staff of an advisory committee, provided that the agency has authority to accept such services without compensation.

e. Reimbursable travel expenses for advisory committee members and staff. The members of an advisory committee, and the staff thereof, while engaged in the performance of their duties away from their homes or regular places of business, may be allowed travel expenses, including per diem in lieu of subsistence, as authorized by 5 U.S.C. 5703 for persons employed intermittently in the Government service.

12. Effective date. The provisions of this Circular are effective on May 1, 1974.

1. Purpose. This Transmittal Memorandum amends Section 7(a) of Circular No. A-63, Revised, dated March 27, 1974.
2. Amendment The 2nd paragraph of Section 7(a) is revised to read as follows:

Before a committee can be renewed by an agency, the agency head shall inform the OMB Secretariat by letter not more than 60 days nor less than 30 days before the committee expires of the following: (a) his determination that renewal is necessary and is in the public interest; (b) the reasons for his determination; (c) the Agency's plan to attain balanced membership of the committee; and (d) an explanation of why the committee's functions cannot be performed by the agency or by an existing advisory committee.

If the Secretariat concurs, the agency head shall certify in writing that the renewal of the advisory committee is in the public interest and shall publish notice of the renewal in the Federal Register and shall file a new charter.

3. Effective date. This Memorandum is effective immediately. Its provisions should be applied to all committee renewals.

SUBJECT: Advisory Committee Management -- Uniform Pay
Guidelines

1. Purpose. This Transmittal Memorandum clarifies Section 11, Circular No. A-63, Revised, dated March 27, 1974, relating to pay and other compensation of members, staff, and consultants of advisory committees.

2. Background. Section 7 of Public Law 92-463 provides that "the Director, after study and consultation with the Civil Service Commission, shall establish guidelines with respect to uniform fair rates of pay for comparable services of members, staffs, and consultants of advisory committees in a manner which gives appropriate recognition to the responsibilities and qualifications required and other relevant factors." Pursuant to the foregoing authority, the Director included uniform pay guidelines as Section 11 of Circular A-63, March 27, 1974. The revisions set forth below are designed to clarify Section 11.

3. Revisions.

(a) Renumber the present subparagraphs a., b., c., d., and e., of Section 11 as subparagraphs b., c., d., e., and f., respectively.

(b) Insert the following as subparagraph "a.":

"a. General

(1) Authority. The guidelines in this paragraph are established under the authority of Section 7(d) of the Federal Advisory Committee Act, 86 Stat. 773.

(2) Applicability. The guidelines in this paragraph shall apply to the pay of members, staff, and consultants of an advisory committee, except that

nothing in this paragraph shall affect a rate of pay or a limitation on a rate of pay that is specifically established by statute or a rate of pay established under the General Schedule classification and pay system in Chapter 51 and subchapter III of Chapter 53 of title 5, United States Code."

(c) Add the following new subparagraph "g.":

"g. Nothing in this paragraph shall prevent -

(1) an individual who (without regard to his service with an advisory committee) is a full-time employee of the United States, or

(2) an individual who immediately before his service with an advisory committee was such an employee, from receiving compensation at the rate at which he otherwise would be compensated (or was compensated) as a full-time employee of the United States."


4. Explanation. New subparagraph "a(1)" is added to state the authority for establishment of the uniform pay guidelines.

New subparagraph "a(2)" is added to clarify the applicability of the guidelines by making it clear that the guidelines do not affect the rate of pay or a limitation on a rate of pay that is specifically established by statute or a rate of pay established under the General Schedule classification and pay system.

New subparagraph "g" is added to clarify the status and pay of full-time Federal employees serving on advisory committees.

5. Effective Date. This Transmittal Memorandum is effective immediately.

TO THE HEADS OF EXECUTIVE DEPARTMENTS AND ESTABLISHMENTS

SUBJECT: Review of Federal Advisory Committees

The President in his letter of February 25, 1977, expressed his concern about the number and usefulness of Federal advisory committees, and ordered a government-wide, zero-base review of all committees, with the presumption that all committees should be abolished except those (1) for which there is a compelling need; (2) which have truly balanced membership; and (3) which conduct their business as openly as possible consistent with the law and their mandate.

Section 7(b) of the Federal Advisory Committee Act (P.L. 92-463) requires the Director of the Office of Management and Budget (OMB) to conduct annually a comprehensive review of each advisory committee to determine:

- a. whether such committee is carrying out its purpose;
- b. whether, consistent with the provisions of applicable statutes, the responsibilities assigned to it should be revised;
- c. whether it should be merged with other advisory committees; or
- d. whether it should be abolished.

To meet the President's objectives, and the requirements of the Act, the following instructions, and reporting format, are provided for the review of Federal advisory committees, and supersede Transmittal Memorandum No. 3, Circular No. A-63, September 3, 1975.

1. Agency comprehensive review. This review is to be a comprehensive, zero-base review of each advisory committee -- regardless of the authority under which the committee was established, or when it was established or last renewed. The head of each agency, or a senior policy official designated by the agency head, should review the need for,

(No. A-63)

and accomplishments of, each committee in terms of factors such as those enumerated in the attached review coversheet (Exhibit I), with particular attention to the "balance" of membership representation. The review should also take into consideration, and provide an opportunity for, public comments and recommendations concerning these advisory committees, to the maximum extent possible.

Based on this review, a determination should be made to continue, merge, terminate, or revise responsibilities of, as appropriate, each advisory committee established by the agency. Similar actions should be recommended for each committee established by statute or Presidential directive for which the agency has responsibility.

2. Reports. Following the agency's review, the following is to be submitted to the Committee Management Secretariat, OMB, not later than April 15, 1977, for OMB and Presidential review:

a. A review coversheet (Exhibit I) only, in duplicate, for each agency-established committee which is proposed to be terminated.

b. A review coversheet (Exhibit I) and brief explanatory statement, in duplicate, for each committee established by statute or Presidential directive, which is recommended for merger or termination.

c. A review coversheet (Exhibit I) and detailed justification, in duplicate, for each committee which is proposed to be continued.

d. A brief description of the process by which the agency provided an opportunity for public comment on the review, and recommendations for continuation, of advisory committees.

e. A letter of transmittal for the coversheets and accompanying statements, constituting a determination that the continuation of the committees proposed to be continued is in the public interest, signed by the agency head.

**Subpart 101-11.12—Annual Report on
Federal Advisory Committees****§ 101-11.1200 Scope of subpart.**

This subpart prescribes the procedures for preparing and submitting the Annual Report on Federal Advisory Committees.

§ 101-11.1201 Background.

(a) The Federal Advisory Committee Act (Public Law 92-463) requires an annual report to the Congress on Federal advisory committees in existence during the preceding calendar year. Executive Order 11769 of February 21, 1974, delegated responsibility for preparation of this report to the Administrator of General Services.

(b) Data for the annual report is coordinated with data the agencies supply to the OMB Committee Management Secretariat throughout the year and, in compliance with sec. 6(c) of the act, provides the official source of statistical information on the activities, status, and changes in the composition of Federal advisory committees. The annual report is separate from the annual comprehensive review which is conducted in accordance with OMB Circular No. A-63, Revised.

§ 101-11.1202 Definitions.

The following definitions shall apply for the purposes of this subpart.

(a) *Advisory committee.* The term "advisory committee" means any committee, board, commission, council, conference, panel, task force, or other similar group, or any subcommittee or other subgroup thereof that is:

- (1) Established by statute or reorganization plan;
- (2) Established or utilized by the President; or
- (3) Established or utilized by one or more agencies in the interest of obtaining advice or recommendations for the

President or one or more agencies or officers of the Federal Government, except that the term excludes:

- (i) The Advisory Commission on Intergovernmental Relations;
 - (ii) The Commission on Government Procurement; and
 - (iii) Any committee which is composed wholly of full-time officers or employees of the Federal Government.
- (b) *Agency.* The term "agency" has the same meaning as it does in 5 U.S.C. 551(1). That is, "agency" means each authority of the United States, whether or not it is within or subject to review by another agency, but does not include:

- (1) The Congress;
- (2) The courts of the United States;
- (3) The governments of the territories or possessions of the United States;
- (4) The government of the District of Columbia; nor

(5) Exclusions set out in 5 U.S.C. 552.

(c) *Racial/ethnic composition.* This composition is not meant to denote scientific definitions of anthropological origins. The categories are:

(1) *I/A=American Indian or Alaskan Native.* A person having origins in any of the original peoples of North America.

(2) *A=Asian or Pacific Islander.* A person having origins in any of the original peoples of the Far East, Southeast Asia, or the Pacific Islands. This area includes, for example, China, Japan, Korea, the Philippine Islands, and Samoa.

(3) *B=Black, not of Hispanic Origin.* A person having origins in any of the black racial groups.

(4) *H=Hispanic.* A person of Mexican, Puerto Rican, Cuban, Central or South American, or other Spanish Culture or origin, regardless of race.

(5) *W=White, not of Hispanic Origin.* A person having origins in any of the original peoples of Europe, North Africa, the Middle East, or the Indian subcontinent.

§ 101-11.1203 Reports.

The reports prescribed by this regulation have been cleared in accordance with FPMPR 101-11.11 and assigned interagency report control number 1121-GSA-AN. Agencies shall use the documents and procedures prescribed below when preparing and submitting their Annual Report on Federal Advisory Committees. Agencies that did not have advisory committees during the calendar year being reported need not submit a negative response.

(a) *Content of report.* The Annual Report on Federal Advisory Committees shall consist of the original and four copies of each of the following:

(1) Standard Form 248, Annual Report on Federal Advisory Committee, and, if applicable, Standard Form 248-A, Annual Report on Federal Advisory Committee (continuation sheet);

(2) Standard Form 249, Membership List on Federal Advisory Committee, and, if applicable, Standard Form 249-A, Membership List on Federal Advisory Committee (continuation sheet);

List on Federal Advisory Committee;

(3) Standard Form 250, Annual Report on Federal Advisory Committees Summary Sheet; and

(4) A letter of transmittal for the report, signed by the agency head or his designee.

(b) *Preparation of report.* The SF 248, Annual Report on Federal Advisory Committee; SF 248-A, Annual Report on

Federal Advisory Committee (continuation sheet); SF 249, Membership List on Federal Advisory Committee; and SF 249-A, Membership List on Federal Advisory Committee (continuation sheet), shall be completed by the organizational element responsible for the support of the individual committee. The SF 250 and the letter of transmittal shall be completed at the department or agency level. Information for completion of SF 250 is compiled directly from data on appropriate SF 248 and SF 249. (These forms are illustrated in §§ 101-11.4930-248 through 101-11.4930-250.)

(c) *Due date.* This report is due on or before January 15 of each calendar year. Submit the report to the Office of Records Management, National Archives and Records Service (mailing address: General Services Administration (NR), Attn: Committee Management Report Coordinator, Washington, DC 20408).

The data for each subgroup will be discrete and will not duplicate data for the parent committee.

Standard Form 248-A, Annual Report on Federal Advisory Committee (Continued), should be used when additional space is needed to supply the required information for any numbered block on the SF 248. Each group of forms should be numbered separately, i.e., SF 248, Page 1 of 2, SF 248-A, Page 2 of 2.

1. DEPARTMENT OR AGENCY. Enter the name of the department or agency submitting the report.

2. CALENDAR YEAR. The year being reported, i.e., the report due in 1977 will be for calendar year 1976.

3. EXACT NAME OF ADVISORY COMMITTEE. The exact name of the committee as chartered. If a subcommittee or subgroup, list name of parent committee first, then name of subgroup. Add parenthetical explanation of any abbreviations in the chartered name, i.e., MESA Advisory Committee (Marine Ecosystems Analysis). If the name was changed during the year or the committee was reestablished under a different name, give the former name in parentheses. Include for the reestablished committee, the dates of its previous existence. (Example: Lower Rio Grande Valley District Advisory Council (formerly Hartingen District Advisory Council).) [Example: Advisory Committee on Science and Technology and Foreign Affairs, 3/18/72-1/5/75.] If the committee was merged into another during the year, give the name of the latter in parentheses. [Example: XXXX Advisory Committee (merged into YYY Advisory Committee).]

4. COMMITTEE STATUS DURING THIS CALENDAR YEAR (more than one block may be checked)

(A) *New*—Committee chartered for the first time this calendar year.

(B) *In existence at end of calendar year*—Committee will be continuing into the next calendar year and will be reported the following year.

(C) *Terminated by merger*—Committee ceased to function by being merged into another committee during existing charter. See also Block 3.

(D) *Terminated by abolition*—Committee ceased to function by being abolished due to a circumstance imposed, other than merger, during existing charter.

(E) *Terminated by expiration*—Committee ceased to function by expiring as indicated in the charter.

5. ESTABLISHMENT AUTHORITY (Check only one)/SPECIFIC ESTABLISHMENT AUTHORITY. The specific establishment authority will be given in the space following item A, B, C, or D. Specific establishment authority refers to the document authorizing creation of the committee. It is not Public Law 92-463, Federal Advisory Committee Act; a reference to the authority for the governmental function on which the committee is advising; a consulting letter to OMB; or the committee's charter.

(A) *Specifically directed by law*—Creation specifically directed by law (statutory committees). Cite the U.S. Code.

(B) *Authorized by law*—Creation authorized, but not specifically directed by law (with OMB consultation). Cite the U.S. Code.

(C) *Agency authority*—Creation authorized by internal department or agency authority (with OMB consultation). Cite the agency document authorizing the creation and the date, i.e., U.S. Department of Labor, Administrative Order No. 19, March 22, 1959.

(D) *Presidential directive*—Creation directed by Presidential Executive order, memorandum, or proclamation. Cite the Executive order number and date—or the Presidential memorandum or proclamation subject/title and date.

6. COMMITTEE TYPE (must be either A or B—and may also be C).

(A) *Ad Hoc*—An ad hoc committee (for purposes of this report) is one created to serve 12 months or less.

(B) *Continuing*—A continuing committee is one created to serve more than 12 months.

(C) *Presidential*—A Presidential committee provides advice directly to the President.

7. ESTABLISHMENT DATE. The date of the committee's original creation. It will never change. For committees created prior to January 5, 1973, use whatever date has been carried since inception; for committees created after January 5, 1973, use the filing date of the first charter filed:

(a) for Presidential committees, with OMB;

(b) for all other committees (including statutory), with the applicable Congressional standing committee(s).

8. REESTABLISHMENT DATE. The most recent rechartering date of a committee which had terminated.

9. LAST RENEWAL DATE. If any, is the most recent rechartering date, prior to December 31 of the calendar year being reported. This date changes to reflect the most recent rechartering. Use the filing date of any such charter subsequent to the initial charter. If the committee is still under its first charter, indicate "none". For a reestablished committee, this date would be the last renewal date prior to termination.

10. NEXT RENEWAL DATE. The expected date for the next rechartering of the committee. If the committee is not expected to be continued, indicate "none". For a reestablished committee, this date would be the next expected date of rechartering based on the current establishment charter.

11. TERMINATION DATE. The date the committee will cease functioning by merger, abolition, or expiration. If there is no expected termination date, indicate "none".

12. BRIEF STATEMENT OF FUNCTIONS. A brief statement of the committee's functions. This should not be the full functional statement.

13. TOTAL NUMBER OF ALL REPORTS SUBMITTED DURING THE CALENDAR YEAR BY THE COMMITTEE. Provide a count of all written reports that have been submitted by the committee during the calendar year. Minutes of meetings, this annual report to GSA, the annual comprehensive review to OMB, and the report of closed meetings to the Library of Congress are not to be listed as reports. List the title and date of submission of reports submitted during the calendar year.

14. MEETINGS. Meetings held on one or more consecutive days count as one meeting. Meetings held on consecutive days interrupted only by weekends or holidays count as one meeting. If more than one meeting was held on the same day, so indicate.

(A) *Total number of open*—A count of the total number of open meetings held during the calendar year.
